Respected Sir,

With due respect, we are forwarding herewith the representation dated 01.04.2019 received from our Circle Secretary, Tamilnadu Circle regarding arbitrary reduction of Last pay drawn of the Telecom Mechanics placed in Lineman Scale before absorption as TM against sanctioned vacancies.

In this regard, it is submitted that in the cases of Regular Mazdoor/ Group D , who have completed TM training were placed in Linemen scale against 23,000 posts of RM upgraded as LM as per demand of unions . This placement is on regular basis as it is as per recruitment rules of Line Man as per DOT New Delhi O.M. No. 1-42/MPP-98 (Pt), as such it is to be treated as Substantive pay. Now on promotion as Telecom Mechanic also their pay is fixed with reference to pay of Line man and it is also on regular basis as such it cannot be reduced except on the ground of punishment. Letter of our Tamilnadu Secretary is self explanatory which may be considered in its letter and spirit for extending justice to the entire cadre of RM/Gr D who trained and promoted as Telecom Mechanic.

In view above, We earnestly request your honour to go through his case thoroughly and arrange to issue necessary instructions to concerned section to do needful in the matter as requested by the Our Secretary at the earliest.
